The observations were made at the seminar titled "The Role of SARCO as an Arbitration Centre in the Region" held at the auditorium of Dhaka Chamber of

Commerce and Industry (DCCI).

Bangladesh International Arbitration Centre (BIAC), DCCI and South Asian Association Regional Cooperation (SAARC) Arbitration Council (SARCO) jointly organised the programme.

President of DCCI Hossain Khaled delivered the address of welcome. Law Minister Anisul Huq was present as the chief guest. Chief Executive Officer (CEO) of BIAC Muhammad A (Rumee) Ali made concluding remarks.

The law minister said the economy of Bangladesh has been consistently progressing with multiple local and cross-border trade and business over the past decade.

"Global trade worth of US \$600 billion remains unrealised due to sluggish business and trade dispute where Bangladesh accounts for around \$400 million caused by disputes," he mentioned.

The minister added: "Alternative Dispute Resolution alongside the conventional judicial system is the commencement of a new chapter in

Bangladesh."

SARCO is an institutional platform where disputes arising from business and trade deals can be dealt with care, impartiality and professionalism, he said.

ADR culture through mediation, arbitration and conciliation in Bangladesh can be a remarkable catalyst in boosting trade and commerce, Mr Huq said, adding that trust and confidence in ADR could make it more popular and effective in Bangladesh.

President of DCCI Hossain Khaled said SARCO may promote cross-border trade and investment in the SAARC region, creating awareness among the business community for alternate dispute resolution.

Growing commercial disputes and delay in dispute resolution process undermine the potential of SAARC to re-emerge as global trade hub, he added.

"SARCO should focus on credential and efficient settlement of commercial disputes to transform this region an ideal global growth centre," he said.

Chairman of BIAC Mahbubur Rahman said if no more case is filed with the court from tomorrow, it will take a long time to resolve the pending cases.

"In such a situation, arbitration can play an important role in settling disputes in a very quick and cost-effective manner," he said.

He said BIAC and SARCO can provide facilities to ensure that disputes are dealt with in a cost-effective and timely manner. He mentioned BIAC does arbitration, mediation and negotiation. Arbitration under BIAC rules can be resolved within maximum 388 days

Bangladesh has a litigation process that most businesses find it lengthy and frustrating and a key impediment to private sector devel-

opment, he said.

"It cannot be denied that a fundamental requirement for trade and investment to flourish is quick and cost-effective dispute resolutions system. It is possible through alternative dispute resolution (ADR) methods, namely, arbitration and mediation," he added.

Fida M Kamal said ADR becomes useful in effective case management. Most of the developed and developing countries have achieved great success in reducing enormous workload of the courts.

He said ADR system reduces the burden of pending cases in the court.

The economic and business activities in Bangladesh are going ahead rapidly. So, quick and efficient dispute resolution in business transaction is required now, he added.

Director General (DG) SARCO Thusantha Wijemanna his keynote paper highlighted SARCO has been established provide a legal framework in region for fair and efficient set ment of commercial, investm and other disputes.

BIAC and DCCI separat signed memorandum of understa ing (MoU) with SARCO.

DCCI's Secretary General Al Rezaul Kabir and Director Gene of SARCO Thusanta Wijemai signed the MoU on behalf of th respective organisations.

According to the MoU, BIAC SARCO will cooperate to deal w each other's institutional ADR in
